

General terms and conditions



Conditions of the contract

By signing the registration form, the student becomes a student of the Iyengar YogaSchool Amsterdam.

Liability

Neither the Iyengar Yoga School Amsterdam or its employees accept liability for loss, damage or injury of any kind unless directly attributed to actions of gross negligence on part of the IYSA.

Payment

The student is required to pay in full for the lesson term within two weeks of the date of invoice from the IYSA. Special circumstances may be taken into consideration providing that the student makes their circumstances known to the IYSA well in advance of the invoice being sent.

Missed lessons

Should a student miss a lesson, this lesson can be taken at a later date as an extra lesson or carried forward to a following term (In general 12 weeks or more) providing that the student pays in full for the new term.

The Iyengar Yoga School Amsterdam does not refund fees for missed lessons.

Cancellation of lessons by Iyengar YogaSchool Amsterdam

In the unlikely event of lessons being cancelled for a period exceeding 1 week, students will be refunded in full for the cancelled lessons.

Holidays

During the Amsterdam school holiday period there will be no lessons. Holidays will be announced in advance on our website www.iysa.nl

Terminating the contract

Students must terminate their contract in writing one calendar month prior to the commencement of the new lesson term.

In the event of Non attendance of lessons without terminating the contract, students will be liable to pay in full for the lesson fees for a period of one calendar month following the date in which written notification of cancellation is submitted.

Substitute student

With prior agreement of the IYSA it is possible to nominate a substitute student to attend lessons on your behalf for the remainder of the lessons within the lesson term.

Revision of Fees and General Terms & Conditions

The Iyengar YogaSchool Amsterdam reserves the right to revise the lesson fees and the General Terms and Conditions. Amendments will not be applied retrospectively of lesson terms.

Exclusion

Should a student fail to pay the lesson fees in full and within the specified time period, IYSA retains the right to exclude the student from attending lessons. Exclusion from attendance does not release the student of their obligation to pay any outstanding fees in full.

Debt recovery costs

Unless special arrangements are made with the student by the Iyengar YogaSchool Amsterdam, the Iyengar YogaSchool Amsterdam reserves the right to pass on to the student any cost both administrative and (non)judicial, incurred in recovering a debt of the student. The Iyengar

YogaSchool Amsterdam will surcharge at least 15 percent on the total costs with a minimum of € 50.
